Important Notice

Management Quota Admission 2023-24 in various Courses offered by this Institute in affiliation with GGSIP University.

1. The Institute vide Notice dated 31st July 2023 had extended the last date for Obtaining/Submission of "Application Form" from all prospective and eligible candidates desirous to seek Admission under Management Quota category of seats in various Courses offered by this Institute in affiliation with GGSIP University in Academic Session 2023-24.
2. Further in compliance of the Orders of dated 04.08.2023 and 07.08.2023 passed by the Hon'ble High Court of Delhi in LPA 563/2023 in the matter of VIPS Vs. Govt. Of NCT of Delhi and Anr reproduced below:-

"that prospective students can apply online on the portal of the institute as well as offline (in the prescribed form downloaded from the website) of the college against receipt issued from the college) against available seats under management quota."

3. In Compliance of the instruction of the University Notification vide Notification No. 132/2023 Dated 08/08/2023, The Institute is now providing the facility of Online Portal to all Desirous/Prospective/Eligible Candidates willing to apply for Admission under Management Quota Category of Seats in various Programmes/Courses in Academic Session 2023-24 as well with immediate effect.
4. The candidates who have already submitted their Application Form through "Offline Mode" for admission in management quota category of seat of various Courses offered by this Institute in affiliation with GGSIP University need not to apply again.
5. It is the sole responsibility of the Candidate to ensure that they fulfil the minimum eligibility criteria in the programmes they seek admission: the correctness of the details filled with respect to region: category or any other such details for allotment of seat. If at any stage of admission procedure the information furnished by the candidate is found to be incorrect or false the admission to the programme shall be cancelled and all the fees paid will be forfeited.

6. Candidates claiming seat in Delhi "Region" must have passed the qualifying Examination (i.e. 10+2/Graduation) from any of the Institutes/Colleges located in Delhi. Allotment of seats in wrong region on account of incorrect filling of form will lead to cancellation of the allotment at any later stage and candidate will automatically lose the right to the seat in his bonafied region if not available at the time of cancellation of seat.
7. Incomplete Application Form without all required Documents/Certificates will not be considered.
8. The admissions under Management Quota shall be subject to and in accordance with the provisions of Delhi Professional Colleges or Institutions (Prohibitions of Capitation Fee, Regulations of Admissions, fixation of non-exploitative fee and other Measures to ensure Equity and Excellence) Act 2007 (Delhi Act 8 of 2007 Govt. Of NCT Delhi and GGSIP University directives.
9. The reservation of management quota category of seats are as per the provisions of the Admission Brochure of GGSIP University for the Academic Session 2023-24 and the seat matrix of various courses are offered by this Institute in affiliated with GGSIP University are also enclosed.
10. The admission under Management Quota category of seats is purely in accordance with the merit of the candidates on the basis of qualifying examination of respective Courses as per the provisions of GGSIP University Admission Brochure of Academic Session 2023-24 and also the directions issued by the University in this regard from time to time.
11. All admission under Management Quota category of seats are "Provisional" subject to the issuance of the Enrollment No. by the University.
12. **All Applicants/Candidates seeking Admission under Management Quota category of seats of various courses offered by this Institute in affiliated with GGSIP University are advised to visit the official website of the Institute regularly for the Course wise counselling schedule and merit list etc.**
