General Instructions:

- I. The Applicant must carry their Identity Card (Aadhar Card etc.) for personal verification at the time for reporting of counselling.
- II. At the time of allotment of seats, the Applicant will have required to pay part academic fee of Rs. 60,000/- to Accept/ Confirm the allotment, therefore Applicant should carry the demand draft of Rs. 60000/- (Non Refundable) drawn in favour of "Dr. Akhilesh Das Gupta Institute of Technology and Management" payable at Delhi while reporting for Offline Counselling.
- III. The Applicant will lose of any claim to the allotment of seats if they are unable to Carry/Pay Rs. 60,000/- (as mentioned above) at the time of their allotment and they will also not be considering for the subsequent round of "Offline Counselling".
- IV. All the Applicant appearing for "Offline Counselling" must carry all the Documents/Certificates, in original, failing which they shall not be allowed for participation of Counselling.
- V. The Applicants appearing for the "Offline Counselling" will be required to submit an undertaking that He/ She has not taken Admission and will not seek Admission anywhere else in any of the College Affiliated to GGSIP University once the seat is allotted under Management Quota "Offline Counselling" at the Institute for Academic Session 2023-24.

- VII. The Candidates desires to participate in the aforesaid Counselling must report at the Institute before the designated time, latecomers will not be allowed.
- VIII. It is the sole responsibility of the candidate to ensure that they fulfil the minimum eligibility criteria in the programmes they seek admission: the correctness of the details filled with respect to region: category or any other such details for allotment of seat. If at any stage of admission procedure the information furnished by the candidate is found to be incorrect of false the admission to the programme shall be cancelled and all the fees paid will be forfeited.
- IX. Candidates claiming seat in Delhi "Region" must have passed the qualifying examination (i.e. Gradution) from any of the Institutions/Colleges located in Delhi. Allotment of seats in wrong region on account of incorrect filling of form
