General Instructions:

- I. As per University Notification No. 191/2023 dated 01/09/2023, the GGSIP University had announced that the CUET Qualified candidates can also apply for admission in BBA (CET code-125) for Academic Session 2023-24. However such Applicants will be consider for counselling after Exhausted the Merit List of CET Qualified candidates conducted by the University for Academic Session 2023-24.
- II. The Applicant must carry their Identity Card (Aadhar Card etc.) for personal verification at the time for reporting of counselling.
- III. At the time of allotment of seats, the Applicant will have required to pay part academic fee of Rs. 60,000/- to Accept/ Confirm the allotment, therefore Applicant should carry the demand draft of Rs. 60000/- (Non Refundable) drown in favour of "Dr. Akhilesh Das Gupta Institute of Technology and Management" payable at Delhi while reporting for Offline Counselling.
 - IV. The Applicant will lose of any claim to the allotment of seats if they are unable to Carry/Pay Rs. 60,000/- (as mentioned above) at the time of their allotment and they will also not be considered for the subsequent round of "Offline Counselling".
 - V. All the Applicant appearing for "Offline Counselling" must carry all the Documents/Certificates, in original, failing which they shall not be allowed for participation of Counselling.
 - VI. The Applicants appearing for the "Offline Counselling" will be required to submit an undertaking that He/ She has not taken Admission and will not seek Admission anywhere else in any of the College Affiliated to GGSIP University once the seat is allotted under Management Quota "Offline Counselling" at the Institute for Academic Session 2023-24.
