Objective:

The purpose of the visit was to develop the understanding among the students of B.A. LL.B (H) and B.B.A. LL.B. (H), 2nd and 4th semester students about the the working of court, the nature of duties of the Judicial Officers in the matters of Lok Adalat, to observe how the concept of conciliated settlement of dispute works, General Procedure followed in the Lok Adalat, Jurisdiction of the Lok Adalat and the nature of cases that are referred to the Lok Adalat for

settlement.

Brief Report:

The students of CLE, ADGIPS reached Karkardooma Courts, Delhi at 10:00 a.m. to observe the working of DLSA and proceedings of Lok Adalat. The students were divided into four groups and were given the opportunity to sit and learn from the procedures and practices of Lok Adalat proceedings. The students visited different courts such as Family court and Traffic Court where

they observed proceedings of Traffic Challan, Bank loan matters and matrimonial disputes.

The visit also led the students to interact with judges and counsel. Students got in-depth understanding about alternative dispute redressal mechanisms where disputes pending in the court of law or at pre-litigation stage are settled and compromised amicably. It was a great opportunity to get direct courtroom experience. Students interacted with the SH. Vivek Agarwal, Secretary, North-East DLSA, and SH. Lalit Kumar, Secretary East DLSA and SH.Anshul Singhal, Secretary Shahdara DLSA. Faculty Members and Students also got the

opportunity to have an interaction with the media Meri Dilli Meri Shaan and shared their experiences about the visit to the LokAdalat and the importance of Legal Aid Services to promote Justice for all. Thereafter small refreshment packets were made available to each

student by the DLSA.

<u>Learning Outcome</u>: The visit to the National Lok Adalat was a truly enriching experience which helped the students to understand the working of Lok Adalat System. The students were highly impressed and motivated to render pro bono services for the betterment of the society. By promoting awareness about the Lok Adalat and exploring ways to address its challenges can significantly enhance its effectiveness in resolving a wide range of disputes. Also, the interaction with the Judges helped them clear their doubts related to nature of cases to be referred to Lok Adalat and how to get the Case Referred to the Lok Adalat for Settlement.
