Brief Report:

The students of "VOX-JURIS Society", ADGIPS and Centre of Legal Education organized the National Youth Parliament, 2024. The event started by the first session of the day. The agenda of the Lok Sabha was the deliberation on the scope of the right to privacy and data protection. The student representative is part of the Government, and took the stand for the legality of the right to privacy and data protection. The discussion started with the Leader of the House presenting the opening statement as well as laying down the idea of how the Government was trying to implement the right to privacy and data protection. The first session concluded with the debate on whether the right to privacy and data protection are two intertwined concepts that are crucial in today's digital age. While distinct, they work together to empower individuals and safeguard their personal information.

The next session started with a flurry of properly researched debate between the Government and the opposition after the opposition presented a draft that agreed to only one point of the draft by the government. The student representative had active participation in that debate, raising Point of Information as well as raising motions.
